Fund balances as of January 31, 2023: Education: \$2,770,614, Operation and Maintenance: \$168,188, Transportation: \$366,671, and Working Cash: \$138,620. The four Major Fund Balances: \$3,444,093. Total Fund Balance for all funds: \$4,131,793.

The district has \$131,819 more this year compared to last year in the four major funds. In addition, the district has \$151,405 more this year compared to the previous year in total fund balance.
