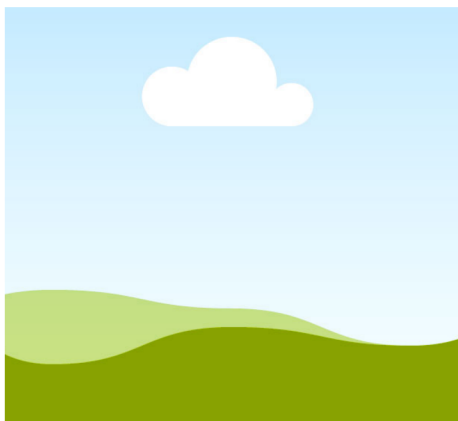

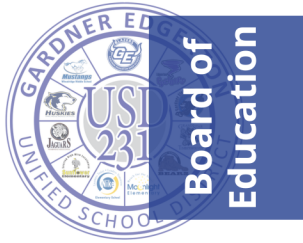

BOARD MEETINGS

Board meetings begin at 6:00 p.m. typically on the first or second Monday of each month at the USD 231 Administrative Offices, 231 E. Madison Street.

The primary role of the Board of Education is to transact the school district's business. The board recognizes its responsibility for proper governance and, therefore, the need to conduct its business in an orderly, transparent, and efficient manner.

Board agendas are provided at each meeting in the lobby of the Administrative Offices. Patrons may also find the agenda and supporting items on the district's website, www.usd231.com (in Board Docs, under the Board of Education).

PATRON INPUT

Patrons can address the board in the Public Comments section of the regular board meeting. Patrons wishing to address the board are asked to complete the Request to Address the Board of Education form, found [HERE](#), or may sign up in person before each meeting. If addressing the board, please:

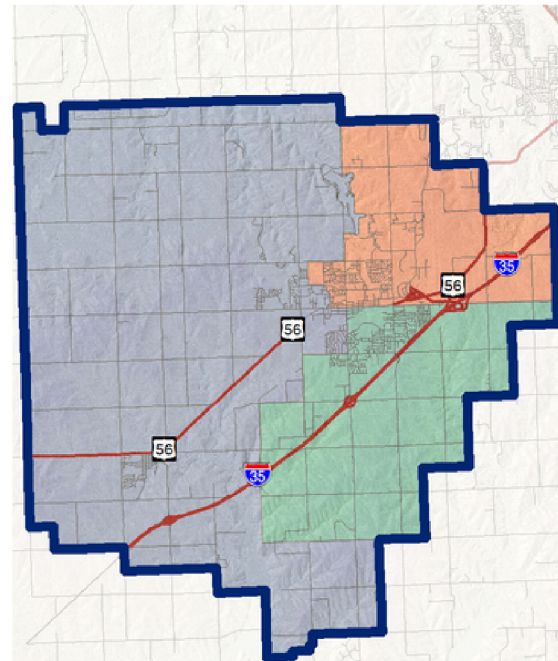
- Complete the information form found [HERE](#) or in person before the meeting;
- When called upon, please approach the podium and use the microphone;
- Introduce yourself by stating your name and address;
- Speakers are limited to three minutes;
- Speakers are encouraged not to use personal attacks and be professional, concise, and respectful;
- Topics regarding complaints related to personnel or student confidentiality should be submitted in writing to the superintendent;
- If using a prepared statement, please have copies for the clerk and the board.

EXECUTIVE SESSION

Once a formal motion is made, seconded, and carried (with the reason for the session being stated), the board may recess to the executive session for discussion. Topics to be discussed in the executive session are limited to non-elected personnel, real estate acquisitions, security, negotiations, or consultation with attorneys.
