Starmount has applied and been accepted for a Global Partner School, which is a part of North Carolina in the World – a program, that at the governor's request, was coordinated by The University of North Carolina Professional Teaching Standards through which we are preparing students to live, work, and compete in the global community. Starmount will be the first school in Northwest North Carolina to be accepted into this program. A team of two or three teachers and an administrator from Starmount will travel to Denmark in October to learn about the country and to teach and observe in their school.
