RIVERDALE LOCAL SCHOOLS INTER-DISTRICT OPEN ENROLLMENT APPLICATION

Guidelines and Application Procedures

The Riverdale Local Schools Board of Education believes that students should, under certain prescribed circumstances, benefit from an inter-district open enrollment policy. Guidelines for the transfer of students, based upon criteria established by the schools' administration and in conjunction with recommendations from officials of the Ohio Department of Education are listed below. These guidelines are intended to be consistent with R.C. 3319.98.

- A. Any applications for an inter-district transfer must be submitted to the Superintendent's office of the Riverdale School District by July 1st. Applications will be acted upon by July 31st. Parents/guardians must indicate acceptance of transfer on or before August 1st. One (1) application must be submitted for each student who requests an inter-district transfer.
- B. For grades K through eight, the inter-district enrollment limits will be two (2) less than the number at which a class size committee would be convened as per negotiated agreement. Presently, those numbers are twenty (20) in grades K-2 and twenty-five (25) in grades 3-8. Class limits at the high school will be on a course-by-course basis.
- C. No student, once accepted, will be displaced should enrollment exceed the limits stated above. The administration will determine building assignment, without guarantee that the building assignment (elementary) will prevail in subsequent years. An application for open enrollment is approved for one (1) year.
- D. Enrollment in a special program, e.g., gifted, learning disabled, developmentally disabled, will dictate which building a student must attend, as units are placed in buildings according to space availability.
- E. School districts are not required to institute any special education programs to serve transfer students. If a student is evaluated for placement in a special education program, representatives of the district of residence must be invited to participate in the placement meeting.
- F. Applicants shall be considered on a first-come, first-served basis with an assurance that native (home) students will not be displaced. Participants in previous projects will be given preference.
- G. Riverdale buses will pick up an incoming student at the first pick up point within the Riverdale District boundary.
- H. The Riverdale School District may deny enrollment to students who have been expelled or suspended for ten (10) or more consecutive days in the current term or the immediately preceding term.
- I. Superintendents may, by mutual agreement, waive the stated enrollment deadline up to August 15th, should extenuating circumstances exist.
- J. Student athletes who transfer to participating districts are subject to the OHSAA by-laws governing eligibility.
