#### Abstract

ARRIVAL AT SCHOOL Students need to arrive as close to 8:25 AM as possible. Students are encouraged to be dropped off at the playground prior to 8:25 AM. The playground supervisors will arrive at 8:05 AM to monitor the needs of students. For safety reasons, students will not be allowed to go to their lockers prior to 8:30 AM unless special permission from their classroom teacher or the office. The dining room will be open for students who are eating breakfast, at 7:45 AM. Students who arrive before 8:00, who are not eating breakfast, may wait in the East foyer and then will be dismissed to the playground.


At the end of the day(3:20 PM), students will be encouraged to go right home after school. Thank you for cooperating with us as we work to ensure the safety of your children before and after school.

If your child has to be absent from school, or late to school, parents are requested to call the school office at (882-6390) between 7:45-8:30 AM. If we do not hear from you before $8: 45$ AM, a routine phone call will be made to determine the reason for absence. NOTE: Whenever your child arrives at school after 8:35 AM they will be counted tardy.

Class attendance is necessary for students to gain optimum benefits from their school experience. South Dakota State Law states that attendance is a responsibility of the parent, although the school will cooperate and assist students and parents to strive toward good attendance practices. Please telephone the school office at 882-6390 to notify us when a student will be tardy or absent. When your child returns to school from a doctor's appointment, a written excuse for our files is required for it to be excused otherwise it is recorded as tardy. Attendance letters will be issued if there is a concern that the student's attendance is chronic and their academic progress is below satisfaction.

## BULLYING(Harassment-Intimidation) Policy JICK

The School District is committed to maintaining a constructive, safe school climate that is conducive to student learning and fostering an environment in which all students will be treated with respect and dignity. The Board expects students to conduct themselves in a cooperative manner through their interactions. Persistent bullying can severely inhibit a student's ability to learn effectively and may have a lasting negative effect on a student's life.

Bullying consists of repeated physical, verbal, non-verbal, written, electronic, or any conduct directed toward a student that is so pervasive, severe, and objectively offensive that it:

1. Has the purpose of creating or resulting in an intimidating,
hostile, or offensive academic environment; or
2. Has the purpose or effect of substantially or unreasonably interfering with a student's academic performance which deprives the student access to educational opportunities.

If bullying does occur, students must inform staff and know that the incidents will be dealt with promptly. Any staff member observing or suspecting bullying toward another individual is required to report the issue to his or her building supervisor.

## ATTENDANCE WORKS

In the 2020-21 school year, at least 10.1 million students nationwide were chronically absent. We estimate chronic absence has more than doubled from the more than 8 million students, pre-Covid-19, who were missing so many days of school that they were academically at risk. Chronic absence - missing 10 percent or more of school days due to absence for any reason-excused, unexcused absences and suspensions-can translate into students having difficulty learning to read by the third-grade, achieving in middle school, and graduating from high school.

## GOOD SCHOOL ATTENDANCE MEANS...



Too many absences-excused or unexcused-can keep students from succeeding in school and in life. How many are too many? I0\% of the school year—that's 18 missed days or 2 days a month—can knock students off track.

## DID YOU KNOW?

- Starting in preschool and kindergarten, too many absences can cause children to fall behind in school.
- Missing 10\%, or about 2 days each month over the course of a school year, can make it harder to learn to read.
- Students can still fall behind if they miss just 1 or 2 days every few weeks.
- Being late to school may lead to poor attendance.
- Absences and tardiness can affect the whole classroom if the teacher has to slow down learning to help children catch up.

Attending school regularly helps children feel better about school-and themselves. Start building this habit in preschool so they learn right away that going to school on time, every day is important. Eventually good attendance will be a skill that will help them succeed in high school and college.

## WHAT YOU CAN DO

- Set a regular bedtime and morning routine.
- Lay out clothes and pack backpacks the night before.
- Keep your child healthy and make sure your child has the required shots.
- Introduce your children to their teachers and classmates before school starts.
- Develop backup plans for getting to school if something comes up. Call on a family member, a neighbor or another parent.
- Try to schedule non-Covid-19 related medical appointments and extended trips when school isn't in session.
- If your child seems anxious about going to school, talk to teachers, school counselors and other parents for advice on how to make your child feel comfortable and excited about learning.
- If you are concerned that your child may have Covid-19, call your school for advice.
- If your child must stay home due to illness or quarantine, ask the teacher for resources and ideas to continue learning at home.

## Building Social and Emotional Skills at Home

Educators help students learn all sorts of new things, including social and emotional skills. Social-emotional learning helps kids:

- Develop healthy identities;
- Manage emotions and achieve personal and collective goals;
- Feel and show empathy for others;
- Establish and maintain supportive relationships; and
- Make responsible and caring decisions.

Here are six ways you can help your child develop social and emotional skills to bridge learning from the classroom to the home.

1. Encourage connection. Over summer and during the school year, encourage your child to check in with friends and family in person, via video chat, or over text. Especially if your child tends to experience social anxiety, a little regular practice connecting with others can go a long way. After the playdate, check in with your child. These quick conversations can be a helpful learning experience for your child.
2. Think out loud. When your child hears your thinking process, it helps them understand how to cope with frustration and solve problems.
3. Read bedtime stories. This end-of-theday routine is an ideal time for talking about feelings. Discuss the characters

and events in the story. Invite your child to share their thoughts and feelings by asking questions.
4. Work together. Instead of asking your child to do a chore alone, do it with them. Together, you might fold laundry, set the table, rake leaves, or paint a room. Help them join in by shortening the handle of a broom to make it child-size or providing a small paintbrush or roller.
5. Play games. Card and board games and outdoor games such as tag or hopscotch offer built-in opportunities for helping children learn to take turns, cooperate, handle frustration, and more. While playing games together, focus on fun instead of winning or losing.
6. Have fun with emojis and memes. Get your child together with friends, including new friends who will be in class with them, to talk about how they all feel about starting the new year. Have them take turns sharing what they're looking forward to the most and what hesitations they might have.

## Pick ups \& drop offs

Thank you for working with Jefferson Staff to keep safety at a premium. For families that are new to dropping off and picking up your child in the circular, please park on the west side of the circular and have your child/ren exit on the west side of your car onto the sidewalk. Please move down the circular until you reach an opening and park. Once your child/ren has been dropped off, then you may pull out into the moving lane (on the east side of the circular). It is imperative that you are parked by the sidewalk before you let your child out of the car. It is a safety issue.

Also, please discuss with your child about staying on sidewalks and
 not walking in-between cars. There have been accidents in our town where students have darted between cars. If we run with or without our children darting between cars, we are modeling poor behavior.

Thank you for not parking and the staff parking lot before or after school. This area is reserved for the busses only. We do not want our children darting in and out of the bus area. This is for everyone's safety.

## POP TABS

Your child should have brought home a note explaining the changes in the Ronald McDonald Pop Tab Program. They should have also brought home a POP TAB house to fill and return to school as many times throughout the year. Once they bring it to school they will dump it in our large container, keep the house, and receive a coupon for a free ice cream coupon from McDonalds. The act of giving and generosity to help others is the lesson learned.

## K-4 Elementary School Counselors assist ALL students with the following services:

## Classroom Lessons

- Consist of counselor led classroom lessons.
- Implements Second Step curriculum that focuses on skills for learning, empathy, emotion management, problem solving, and personal safety.
- Occurs throughout the school year.


## Collaboration with Staff and Parents

- Attend team meetings to discuss student progress and concerns.
- Communicate with parents about their children's successes and/or concerns.
- Connect parents to community resources.


## One-to-One Visits

- Address a student's area of concern and develop social skills.
- Will occur on a short-term, as-needed basis.
- No long-term, intensive counseling is provided by the school counselor.
- Parents, teachers, or students can also request one-to-one visits.


## Small Group Sessions

- Coordinated to focus on a specific skills or to provide students with emotional support.
- Usually involves 3-8 students.

It is important to note that information a student shares is confidential unless the student's wellbeing is in danger or the student requests we share information. Students, parents and/or guardians, retain the right to discontinue one-to-one visits or small group involvement at any time by contacting the school Principal. If concerns emerge in regards to your child(ren), please feel free to contact us at our respective school buildings.

## Dear Families,

Success in school is not just about reading and math. It is also about knowing how to learn and how to get along with others. The Watertown School District has always taught these critical skills through SocialEmotional classroom lessons. Last year the district is adopted the new digital curriculum available from the Second Step program. This new Second Step program teaches skills in the following areas:
$\downarrow$ Growth Mindset \& Goal-Setting: Students learn how to develop a growth mindset and apply researchbased goal-setting strategies to their social and academic lives.
$\uparrow$ Emotion Management: Students learn how to build their emotion vocabularies, practice identifying their own and others' emotions and recognize the importance of labeling and processing their emotions.
$\downarrow$ Empathy and Kindness: Students learn how to recognize kindness and act kindly toward others and how to develop empathy by learning strategies to take others' perspectives.

- Problem Solving: Students learn how to process strong emotions, describe a problem, identify the wants and need of others and think of and explore the outcomes of potential solutions and pick the best solution.

Our classroom lessons will continue to utilize that Child Protection Units of the Second Step program for our all K-4 students. These units expand the social-emotional learning of our K-4 students using these three skills:

- Personal Safety. Children will learn safety rules and ways to decide if something is safe or not.
- Touching Safety. Children will learn about safe, unsafe and unwanted touches, and about rules to apply regarding these touches. They'll also learn to say no to unsafe or unwanted touches, and to tell a grown-up if someone breaks the touching rules.
- Assertiveness. These lessons will also give children a chance to practice asking grown-ups for help, telling a grown-up about an unsafe situation, and being assertive to get out of an unsafe situation.

## Dear Parents:

You've all read the headlines and seen the news stories: food allergies are a growing concern in schools across America. Millions of children-children who are perfectly healthy and normal in every other way, must watch every single bite they eat, or risk suffering a severe or even life threatening reaction. A major health issue such as this, must be taken very seriously and it has always been the policy of this school to make the safety and well-being of our students, our top priority.

A student in your child's classroom may have a mild to severe allergy to certain foods/peanuts, tree nuts, etc...A child with a serious peanut allergy can suffer a reaction merely by touching peanut containing food. Therefore, we are putting the following safety guidelines into effect:

- It is best practice not to send any peanuts, peanut butter, or foods containing peanuts or peanut butter to be eaten as snacks in the classroom or cafeteria.
* Before bringing treats to school, check with your child's teacher to make sure there are no students with food allergies in the classroom.
* We will not be doing any classroom projects that involve peanut butter (like bird feeders) or peanut shells (art projects) Please do not send any of these projects into the classroom with your child.
* Birthdays are a special time for children, but can be a difficult time for the food-allergic child. Please only send treats labeled with the ingredients. It would be especially helpful if your could let your child's teacher know a few days ahead of when you are bringing treats, so that the food-allergic child can provide his/her own safe treat.
* If your child ate peanut butter for breakfast, we would greatly appreciate your making sure that his/her hands are washed with soap and water before leaving for school. Water alone does not do the trick.

This is a learning process, but we trust that you understand how deeply important it is to respect and adhere to these guidelines. If throughout the course of the year you have any questions or concerns about food-allergy-related issues, please do not hesitate to contact either one of us.

## CITIZEN CONCERNS ABOUT FEDERAL PROGRAM

A parent, student, employee, or District stakeholder who has a complaint regarding the use of federal funds or alleges a violation of a federal rule, law or regulation or state regulation that applies to a federal program may address the complaint in writing to the District's Superintendent.

Disputes addressing the enrollment, transportation (including inter-district disputes), and other barriers to the education of children and youth experiencing homelessness are also addressed under this procedure. Parents, guardians, and unaccompanied youth may initiate the dispute resolution process directly at the school they choose, as well as at the District or District's homeless liaison's office. The parent or guardian or unaccompanied youth shall be provided with a written explanation of the school's decision including the rights of the parent, guardian, or youth to appeal the decision.

Students should be provided with all services for which they are eligible while disputes resolved.

- The Superintendent will investigate, within one week, the circumstances of the complaint and render a decision within two weeks, after receipt of the complaint.
- The Superintendent will notify the complainant of the decision in writing.
- The complainant will either accept or disagree with the decision and will provide such acknowledgement in writing, addressed to the District's Superintendent.
- If the issue is not resolved with the Superintendent, the complaint will be forwarded to the District's School Board for further review. The parent or guardian or unaccompanied youth shall be provided with a written explanation of the District's decision including the rights of the parent, guardian, or youth to appeal the decision.
- Unresolved complaints may be forward by the stakeholder to the South Dakota Department of Education for review-(Consult SD Department of Education Complaint Procedure).
