Athletic Training Services Agreement

This agreement is entered into this 1st day of September 2023, by and between Pinckneyville Community High School, herein after referred to as "PCHS," and Southern Orthopedic Associates, DBA Orthopaedic Institute of Southern Illinois, 510 Lincoln Drive, Herrin, IL 62948, hereinafter referred to as "OISI."

WHEREAS, PCHS has need for athletic training services provided by an Illinois licensed, board certified athletic trainer, hereinafter referred to as ATC, for its student athletes; and

WHEREAS OISI desires to assist PCHS in overseeing the safety and physical condition of student athletes while participating in scholastic athletic events by provision of athletic training services.

NOW, THEREFORE, based upon the mutual covenants herein contained, the parties hereby agree as follows:


1. OISI will:
 - A. Provide guidance as to the appropriate procedures for prevention, assistance, and management of athletic injuries.
 - B. Provide recommendation for exercise and other physical measures for minor injuries under the direction, supervision, and review of the orthopaedic physicians at OISI.
 - C. Make recommendations when requested by PCHS as to improvement to the PCHS facilities in an effort to assist PCHS in appropriate injury prevention and management.
2. The terms of the agreement will be from September 1, 2023, through August 31, 2024. OISI shall pay the sum of \$20,000.00 annually to PCHS and will be billed \$5,000 at the beginning of each quarter by the school.
3. PCHS will:
 - A. Provide recognition to OISI as the "Official Sports Medicine Provider for PCHS Athletics" on the PCHS athletics website and in official PCHS athletics publications.
 - B. Provide OISI signage on/in PCHS athletics facilities as deemed appropriate, but at least in/on football, basketball, and baseball facilities.
 - C. Co-branded PCHS/OISI uniforms produced by Pinckneyville Community High School.
4. This agreement shall begin as of day and month as first written above in section 2 and shall remain in effect through August 31, 2024. Either party may terminate this agreement by providing the other party 90 days written notice.




